This Indenture made this eighth day of February, eighteen hundred and six, witnesseth that Negro Jane ~~to~~ Jenny, being this day manumitted by Zebulon Hollingsworth Esq^r of Elkton in Cecil County on condition that she serves him his heirs or assigns as an Apprentice until she arrives at the age of twenty eight years which will be on the eighth day of February eighteen hundred and twenty one as by said manumission among the Records of Cecil County will appear, doth put and by these presents doth hereby put place and bind herself unto the said Zebulon Hollingsworth and with him or his assigns after the manner of an apprentice to live from the day of the date hereof until she arrives at the age of twenty eight years which will be on the eighth day of February eighteen hundred and twenty one she being at the date hereof thirteen years of age, And the said master shall teach or cause his said Apprentice to be taught the art, mystery and business of Housewifery. And the said Apprentice shall in all things lawfully well ~~and~~ faithfully serve her said master and do the same to the utmost of her power, his lawful commands readily obey, his secrets keep, and during the time of her apprenticeship aforesaid, she shall not absent herself from the service of her said master, but in all things and at all times she shall behave herself during the whole term of her apprenticeship aforesaid as a good

and faithful apprentice ought ~~to~~ last,
the said master shall find and provide his said
apprentice during the time of her apprenticeship
with sufficient meat drink washing lodging and
apparel fitting for such an apprentice, and
also give her at the expiration of her time a pair
of shoes, besides the common wearing apparel one
